TEKAMAH-HERMAN COMMUNITY SCHOOLS

SCHOOL BOND ELECTION

“Shall Burt County School District 0001 (Tekamah-Herman Community Schools) issue its bonds in a principal amount not to exceed \$34,995,000? ... Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?”
