
The Burt County Board of Supervisors met in regular session on Thursday, June 30, 2016 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Lyons Mirror-Sun, upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Cliff Morrow, David Schold, Greg Brummond, Matt Connealy, Perry Rogers, Ted Connealy and Gerald Newill.

The meeting opened at 9:00 A.M. upon motion by Rogers, seconded by Newill, with roll call vote as follows: Ayes – Schold, Brummond, M.Connealy, Rogers, T.Connealy, Newill and Morrow. Nays-none. Chairman Morrow informed the public that the Nebraska Open Meeting Act was posted on the wall.

RESOLUTION # 2016-09 A RESOLUTION OF BURT COUNTY ADOPTING THE Papio Missouri River Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan

WHEREAS the governing body of the Burt County recognizes the threat that natural hazards pose to people and property within the County; and

WHEREAS the Papio Missouri River Natural Resources District has prepared a multi-hazard, multijurisdictional hazard mitigation plan, hereby known as the 2016 Papio Missouri River Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS the Papio Missouri River Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in Burt County from the impacts of future hazards and disasters; and



NOW THEREFORE BE IT RESOLVED by the Burt County Board of Supervisors that \$4,223.70 be transferred from the General Miscellaneous budget to the County Attorney budget and \$805.70 be transferred from the General Miscellaneous budget to the County Surveyor budget.

Upon motion by Schold, seconded by Brummond, the Board went into Closed Session with Attorney Dave Drew at 10:00 A.M. to discuss legal actions brought against the County, with roll call vote as follows: Ayes – Schold, Brummond, M.Connealy, Rogers, T.Connealy, Newill and Morrow. Nays – none. Upon motion by Rogers, seconded by T.Connealy, the Board went back into Regular Session at 10:28 A.M., with roll call vote as follows: Ayes – Schold, Brummond, M.Connealy, Rogers, T.Connealy, Newill and Morrow. Nays – none. No action was taken.

Supervisor Newill spoke of the weeds being seen this year. He suggested the County put out information to the public with regards to combatting/controlling weeds that are being seen.

Peggy Smith, Hwy. Superintendent brought back information from other counties as far as how many have a mix of active/inactive TWPs. Fillmore County is the only other county she spoke with that has both; so there really is no knowledge to be gained from our





peers. Matt suggested that he'd like to look into more Legislative history before the Board makes any suggestions/decisions.

Matt Connealy, Supervisor Dist.4 had a constituent ask him to look into closing the North end of County Road 27 (a minimum maintenance road). Smith explained that because it is a County Line, there are several factors that need to be looked at; but she'll do some initial work up for details of the road, travel, property ownership, etc.

Upon motion by M.Connealy, seconded by T.Connealy, Chairman Morrow signed the **Subgrant Agreements for the Attorney's Office and the District Court. Agreements are written up between the Nebr. Dept. of Health and Human Services -Division of Children and Family Services Child Support Enforcement and Burt County, with roll call vote as follows:** Ayes – Schold, Brummond, M.Connealy, Rogers, T.Connealy, Newill and Morrow. Nays –none.

There being no further business to come before the Board at this time, the meeting adjourned at 10:57 A.M. until 9:00 A.M., July 12, 2016.
