The Burt County Board of Supervisors met in regular session on Friday, July 29, 2016 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Lyons Mirror Sun, upon a 1<sup>st</sup> floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. Pete Ueding, Building and Grounds, came in for discussions of projects needed in and around the Courthouse grounds. **Updating of the public restrooms** in the Courthouse will be needed in the coming years, but ADA requirements will affect the plans due to bigger space requirements than we currently have. Bathroom updates will be more involved than just fixture changes, etc.; so the board will have to keep this in mind and start planning now for timing and financial purposes. Current bathrooms are running properly, so discussions were for proactive future planning only. The row of **trees** that line between the sidewalk and alley are diseased. There is a need to replace this backdrop of trees on both the North and South side of the Courthouse. It is recommended by John Wilson to put in Japanese Lilac Trees; 6 on the South and 4 on the North. This species is recommended because of the upward growth and its smaller size. Papio-Missouri NRD does have Grants available that we will apply for. Project timeline will be Spring 2017.

There being no further business to come before the Board at this time, the meeting adjourned at 10:42 A.M. until 9:00 A.M., August 9, 2016.
